Work Place Health, Safety, and Environmental Protection Starts With You!

Proper Attire & PPE: Wearing the appropriate clothing and proper Personal Protective Equipment (PPE) is essential in reducing accidents and personal exposures. Know the risk potential and the requirements before operating and handling equipment and materials. Contact the EH&S office if you have questions regarding proper attire and PPE.

Training and Documentation: Training is a fundamental tool that educates and aids in reducing associated risks. Understanding and performing tasks to your best ability supports a safe working environment for yourself and those around you. Training is specific to the task you are performing and are outlined by your superior. These work procedures (SOPs), job safety analyses (JSAs), and hazard assessments detail out the hazards you may experience in the tasks you perform. They will provide you guidance on conducting your work safely. Check with your supervisor to review them. Who needs training? You, as an employee, student or select visitor or volunteer need the training.

Documenting your training is equally important as completing the required training. Documentation consist of your signature and date the training was understood and completed for each section of training identified. Documentation is vital to demonstrate that training was completed as it is reviewed by inspecting agencies.
