- As a representative of the Director, and in cooperation with local extension boards and county commissions, this position will develop budgets ensuring compliance with Kansas Extension Council and District laws. They provide administrative leadership to the following units: Pawnee County, Reno County, Harvey County, Butler County, Sedgwick County, Cowley County, Sumner County, Harper County, Kingman County, Barber County, Pratt County, Comanche County, Kiowa County, Clark County, Ford County, 21 Central District.
- Supporting professional development and personal growth of the faculty and staff in the delivery of high-quality, relevant, and effective extension educational programming.
