Acceptance of October 19, 2021 Annual Meeting Minutes; Gary Fike moved; Jennifer Brantley seconded approval of the minutes as written.

Executive Committee Report

- Chair David Key reported the Executive Committee met to plan for this meeting. The minutes
 will be posted to Teams as soon as Trudy gets her awards, we didn't want to spoil the surprise.
 Other actions taken: during the last annual meeting KACDEP asked the Executive Committee to
 decide whether to make a new DEI committee to align with NACDEP Committees. The
 Executive team decided to make DEI part of each committee's description.

- Membership/Professional Development Marlin Bates, Jennifer Brantley, Ron Wilson, Frances Graves, Rial Carver
 - 1. Reported on the online training in 2021 and the 2021 Pre-conference.
 - 2. Marlin asked for new members to join the effort as there is a lot of work to be done.
- Members expressed appreciation for an effective fundraising effort which supports our mission.

- Policies and Procedures David Key. The committee met and decided there were no changes needed.
- Budget/Fundraising Nancy Daniels presented the cash report and the 2022-23 budget noting
 the major changes were to increase the scholarships to PILD and JCEP to more closely
 approximate total expenses. This acknowledges our priority on helping our leadership attend
 and is aligns with other KSRE professional associations.
- Awards/Recognition Tara Markley, there were no awards submitted this year. It was suggested that we go into PEARS and look at all the work being done and systematically ask people to be nominated. We will put "Awards" on the agenda for the Spring KACDEP and do some thoughtful consideration of who should be nominated for NACDEP awards.
- Nominating Tara Markley. Frances Graves has agreed to be the President-Elect.
- NACDEP Committee Representation- Jaime Menon and Jan Steen. Jaime and Jan pointed out the most recent NACDEP newsletter, which they edit. Jaime reiterated that her service on a KACDEP committee had given her the opportunity to get to know a great group of people across the country. Wednesday Webinars have been ramped up, these are presentations which applied to be NACDEP conference sessions and were not accepted for conference presentation but were of value to be shared. The North Central Region has a library of programming which can be searched and utilized. January 13, 2023 NCRCRD will visit KSU and want to hear from us.

- Annual Conference Committee Representation Jennifer Brentley said she had been happy to represent us.

Old Business

• DEI Committee:

Last year in a discussion of aligning KACDEP's committees with NACDEP, the Executive committee was asked to decide how to address DEI issues. The Executive Committee decided to incorporate a priority on DEI into each committee description; the change has been made. Elaine Johannes suggested that we use the acronym DEIB, Jaime seconded. This is a brand new effort by KSU to add the word "Belonging" for those who feel unincluded.
