All meetings have been conducted according to appropriate parliamentary procedure. A slate of officers was presented by the nominating committee and voted on electronically by eligible members prior to the Annual meeting.

Treasurer - Sheryl Carson, Kearny County

September 24, 2014

Since November 13, 2012 when I assumed the treasurer's responsibilities our total income has been \$45,896.87 (which includes the transfer of funds from the Leoti bank.) The total of expenses has been \$23,756.42. The overall total is \$22,140.45.

Since our meeting October 2013 the income has been \$13,031.90 and our total expenses have been \$10,680.13 for an overall total of \$2,351.77.

As yet, the only Friendship Night 2014 expense request that has come due is the required deposit of \$100 for Sunset Zoo. Frequently there is an overlap of income and expenses from one year to another in the transition from fiscal year to fiscal year. You see an example of that with the Friendship Night line item where it says \$192. Friendship Night 2013 income was \$2053.44. Friendship Night income is received in the following fiscal year.

The checking account interest since November 2012 is \$40.93 of which \$24.46 of it has accrued since October 22, 2013.

A fifty dollar donation was paid to ALS in honor of Connie Bretz's retirement. Connie is an honorary member of KEAFCS.

KEAFCS picked up \$1500 from the United Associations Conference this year. Last year it was \$2760.

This year KEAFCS has 69 members plus one lifetime member, Bev Dunning. \$7200 in dues has been paid to NEAFCS. That includes \$300 NEAFCS lifetime dues for Bev Dunning paid for by Bev. Retired lifetime members do not pay affiliate dues. New members pay \$120 while renewed membership is \$130 and KSRE Specialists pay \$124.

October and November are important months to join or renew membership to take advantage of NEAFCS benefits before the January 1 deadline. Please, consider renewing your membership before December since the holidays interfere with processing to meet the January 1 deadline. Please encourage recruitment of new members before December, as well. Members may join or renew at any time of the year.

KEAA Dues was \$408 for 2014.

Vice President of Professional Development - Amy Lorenzen, Golden Prairie District

The 2014 United Association Conference was held in Wichita Thursday and Friday March 6-7. This year's theme was Resilient in the Heartland. KEAFCS was in charge of exhibits on Thursday. One hundred forty-six attended the conference including 25 KEAFCS members. Profit from this conference is distributed to the participating organizations. The payout was \$60 per member, so yielded \$1500 for our association.

The group voted to create a leadership rotation among the four participating associations. KAFCS will chair in 2015, KEAFCS in 2016, ESP in 2017 and KATFCS in 2018.

Twenty-three organizations were represented in the exhibits, either in person or by sending catalogs and door prizes.

I think there is still room for improvement, as there was a lot of vacant space. Part of that is because several of the booths reserved for sponsors canceled at the last minute. The tables were already set up, so it LOOKED like there were no-shows. I think we need to give more thought to how to attract vendors for a crowd of 150, then how to support the vendors. Should the exhibit time be shorter?? It was 9 - 3:30 this year.

The 2015 Conference is scheduled for March 5-6 in Wichita, and at this time, we are still looking for KEAFCS members to serve on this committee. Currently, the committee members from KEAFCS are: Denise Sullivan and Amy Lorenzen.

Numerous Kansas family and consumer science educational programs lead by KEAFCS members were highlighted in 2014 NEAFCS Impact Statement reports. (<http://www.neafcs.org/impact-statements>) Information was shared with national and state decision makers. Kansas joined other NEAFCS affiliates to compile national impact statements. Information was shared for the following categories: Protecting Our Family Resources, Improving Children's Lives, Healthy Homes and the Environment, Financial Management, Food, Nutrition and Health, Childhood Obesity, Food Safety and Community Health and Wellness.

Attendance at the annual session for affiliate session for vice president of public affairs provided an opportunity to receive additional information about the 2015 impact statements as well as discussion regarding public affair programs for NEAFCS membership, involvement in the national organization and Living Well. Members are encouraged to use the Living Well branding during the year and plan local, regional and state-wide events during the month of March. During the year, a variety of methods were used to promote the national Living Well campaign to tell the value of Extension Family and Consumer Science programs by KEAFCS members. A packet of Living Well marketing resources is available in each county office.
