The NW Area FCS agents have been very busy this year. At our December meeting we met with our area specialist and program assistants in LaCrosse with Erin Petersilie as our host. We shared different program ideas and set up several dates for meetings. We also enjoyed each other and had some great fun!

This year has been very productive in the NW Area. Even without a FCS Specialist since Libby Curry's retirement in December our agents have been busy continuing with two very successful area wide programs: "Full Circle...Living Life, An Aging Expo" and "Preserving the Families with Estate Planning". # Professional Development

## **Vice President Professional Development – Teresa Hatfield**

The 2016 United Association Conference was held in Wichita at the Sedgwick County Extension Education Center March 3<sup>rd</sup> and 4<sup>th</sup>. This year's theme was "Innovate, Integrate, Motivate, Educate". Jody Cross was the key note speaker with the topic of "Leader Speak". The conference had 159 in attendance, which was up 25 from last year. KEAFCS had 23 members in attendance. Payouts to participating organizations are based on attendance. This year the payout amount is \$60 per member. Our association received \$1,380 from the conference.

Of those that completed the evaluation most of the participants were very satisfied with the conference. "Hot topics" - was once again a very popular session, and this year there was room for everyone to attend. Some of the sessions may need further clarification of the topic in the registration. Discussion at the wrap up included ideas on; tracks for young and experienced professionals, using QR codes for programs, re-evaluate dining with friends because of lack of participation, and reviewing student rates to at least cover the cost of their lunches.

Changes that will be made next year include; a \$500 contribution to the Sedgwick County Extension for the use of the facilities, the conference will provide laptops and projectors, and three registration fees waived for Sedgwick County Extension FCS agents.
