## CHELSEA RICHMOND, TREASURER.

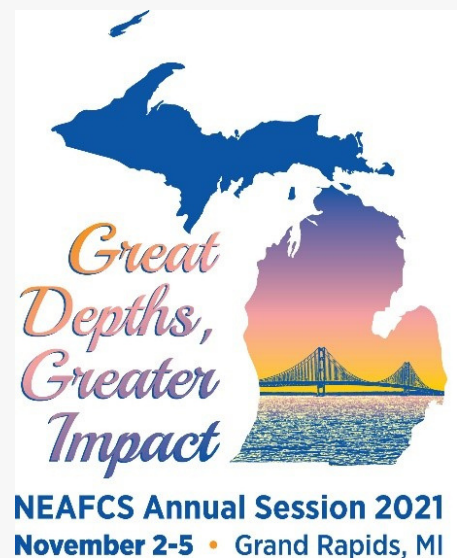

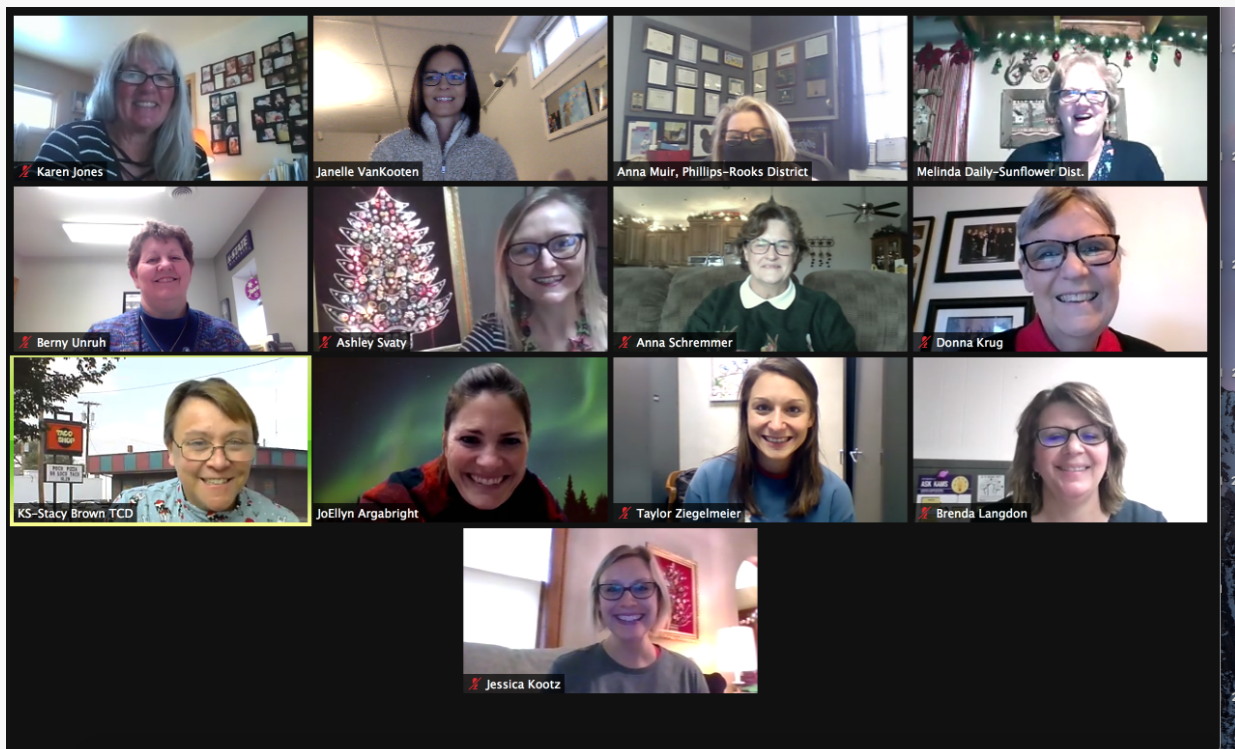


# ASHLEY SVATY, NW AREA COUSELOR.

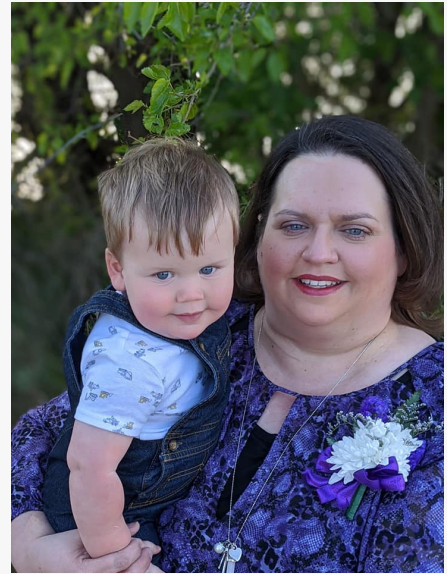
