New Business-Tara reported on conversation she had with Gregg Hadley about the past history of the Ask the Administrator format that has been used for quite some time first with KEAA and most recently with KSJCEP.

Gregg shared the following possible discussion topics with Tara of some possible direction for our next Ask the Administrator session with those being:

- 1. Increased agent participation in PILD
- 2. Agent promotion model
- 3. Recruitment and retention of KSRE employees

He also encouraged future discussions be focused on 1-2 high priority issues to solve with KSRE administration at a time. Ideas were shared by several members with discussion relating to how we narrow down the "bullet list" of high priority issues and get feed back from the membership to make our September meeting a productive and successful session.

Jill Martinson shared the purpose and mission of KS JCEP with everyone in the chat room which helped focus our discussion and thought process. (promote teamwork and cooperation among all agent associations in a positive manner, collaborate and maintain positive relationships with KSRE Administration, Extension Councils and affiliated KSU Departments, etc.)

A consensus decision was made step away from the bullet point list and to develop a Qualtrics survey for the KSJCEP membership to concentrating on the three discussion topics that were shared by Gregg. The survey would allow for written feedback that will be shared at our September 22, 2022 meeting with KSRE Administrators.
