National Board – **Beth Claypoole** reminded the group that the Requests for Proposals for Concurrent Sessions, Posters and Ignite sessions are due March 15 and are currently on the <u>National ESP website</u>.

National Office – Greg Price asked for clarification on State's Night Out. There will be heavy hors d'oeuvres served with the auction. States can then go out together if desired.

Keynote Speakers – John Forshee and Jennifer Wilson updated the group on signed agreements with each speaker. Nausler and Richardson have agreed that their presentations can be live-streamed for ESP members who aren't able to attend the conference in person. Jennifer will talk with Taulbert next week.
