

# SNAP-Ed Nutrition Assistant, Wildcat District

## About this Role:

The Extension Nutrition Program, within K-State Research and Extension, is currently seeking a part-time SNAP-Ed Nutrition Assistant. Nutrition Assistants serve to meet the Kansas Supplemental Nutrition Assistance Program Education (SNAP-Ed) mission of empowering low-income Kansans using evidence-based strategies to achieve healthy lives and reduce health disparities. Specific strategies include direct education in various settings, community-based projects to address policy, system or environmental changes and public health approaches to help children, families and adults improve dietary quality and food resource management skills and increase physical activity. This position reports to the Wildcat District EFNEP/SNAP-Ed Extension Agent.

## Duties Include, but are not limited to:

- Collaborating with district Extension Agents and Nutrition Educators to assess the nutrition and health needs of low-income residents.
- Coordinate, prepare and deliver curriculum-based nutrition education programming to limited resource groups and individuals of various ages in settings such as: Housing Authorities, Food Banks, Schools, etc.
- Develop partnerships and contacts with local service agencies, school districts and other community organizations.
- Serve a local SNAP-Ed program and K-State Research & Extension representative for Wildcat District.
- Participate in local community coalitions to promote, implement, and support initiatives for Policy, System and Environmental changes related to SNAP-Ed goals and objectives.
- Gather data and compile county SNAP-Ed reports and records for submission to the state SNAP-Ed office on a monthly, quarterly, and annual basis.

### Location:

This position will serve Crawford County, KS as a member of the Wildcat District, which has offices in Altamont, Fredonia, Girard, Independence, and Pittsburg. **The primary office location will be in Pittsburg, KS.**

Regular travel within Crawford County is required.

### Hours and Pay:

This position will require approximately **18 hours per week** and will be paid **\$15.00 per hour**.

Application screening will begin **immediately** and continue until the position is filled.

In addition, we promote, implement and support initiatives for Policy, System and Environmental changes to improve dietary quality, prevent obesity and increase physical activity.

SNAP-Ed is sponsored by the USDA through a contract with the Kansas Department for Children and Families (DCF) and implemented by Kansas State Research and Extension (KSRE). Programming takes place in 75+ counties through the efforts of County Extension Agents, Nutrition Educators and Nutrition Assistants.

### What you'll need to succeed:

#### Minimum Requirements

- Enrolled in at least six credit hours during the academic year. During the summer session, students must (a) be enrolled in at least one credit hour, (b) have been enrolled in six credit hours the preceding spring semester, or (c) be pre-enrolled in at least six credit hours in the upcoming fall semester.

#### Preferred Qualifications

- Pursuing a degree in Nutrition, Family and Consumer Sciences, Public Health, Education, or a closely related field
- Knowledge, experience, or interest in working with limited resource families, diverse audiences and subject matter including food safety
- Exemplary written and verbal communication skills, confident speaking in front of groups and facilitating meetings
- Knowledge, experience, or interest in public health approaches to promote policy, system and environmental changes and improve access to healthy food and physical activity opportunities
- Demonstrated leadership skills
- Ability to communicate effectively with both English and Spanish-speaking learners.

#### Other Requirements

- **Applicants must be currently authorized to work in the United States at the time of employment.**
- At least 16 years old
- Valid driver's license, proof of vehicle insurance and reliable transportation
- Students must be enrolled in a post-secondary education program other than Kansas State University
