



In several 'titles' of the Farm Bill

Today there is \$650 million dollars annually of mandatory funding

Mandatory funding of local and regional foods programs* increases in the 2002-2018 Farm Bills


Some specialty crops have established insurance options

Varies both by geography and crop

Market size is a challenge for insurance access Kansas growers

The only vegetables (excluding dry peas and beans) insured in 2024 were onions (9 policies sold) and potatoes (\$4.9 million revenue covered for \$133K producer premium)

Nursery policies (6) covered \$7.9 of revenue for about \$28K producer premium



Notes: **FCIP** = Federal Crop Insurance Program. **NAP** = Noninsured Crop Disaster Assistance Program. **Dry peas** include dry chickpeas and lentils. **Squash** data exclude applicants flagged for fraudulent activity.

Whole Farm Revenue Protection (WFRP) / Microinsurance



WFRP insurance covers **all** revenue for a farm operation, designed for smaller, diversified farms, including those serving local and regional markets

Potential benefits: offers good value for risk protection, continued efforts to streamline and make more favorable

Potential drawbacks: Schedule F required, paperwork, finding an agent who can and will write a policy, yield and price may not be primary risk

7 policies sold in 2024, 2 "earned premium" to date, covering \$4.6 million of revenue for \$71.5K producer premium

Heartland Farm to School/ECE Institute






Heartland Farm to School/ECE Institute

- Collaboration between KSDE, MDE, NDE made possible with USDA Formula Grant Funds
- Modeled after the <u>Northeast Farm to School</u> <u>Institute</u> in Burlington, VT

Heartland Farm to School/ECE Institute

- Modeled around the <u>Three C's of</u> Farm to School
 - Classroom
 - Cafeteria
 - Community



Heartland Farm to School/ECE Institute

- Three teams selected from each state to participate in each Institute.
- Each team will be assigned a coach to facilitat Farm to School/ECE activities throughout the year.
- Technical assistance from each state agency, partnering organizations and cohort of teams.



Requirements to Participate

- Must participate in either the Child and Adult Care Food Program (CACFP) or National School Lunch Program (NSLP), depending on the year.
- Teams must include: a foodservice/nutrition team member, an administrator and an additional person from the Three C's

The Heartland Regional Food Business Center is funded to work across 5 states and a designated tribal trade coalition.

The Heartland RFBC helps farm and food enterprises develop local and regional food businesses and markets. Partners provide assistance from startup through growth, and also support supply chain connections.





Activities of the Regional Food Business Centers:

TECHNICAL ASSISTANCE

- Heartland Food Business Center partners provide direct services to farm and food entrepreneurs, including training and technical assistance, one-on-one business counseling, help accessing financing, and building supply chain connections.
- The Center supports diverse talent, skills, and vision in the food system with an emphasis on reaching and **serving underrepresented and underserved groups**, from small rural and urban farms to indigenous and minority communities.

COORDINATION

- The Heartland Food Business Center partners help farm and food entrepreneurs **connect with other businesses and solve problems** they encounter on their way to market, such as distribution and storage gaps. Such "food value chain coordination" is key to building strong local and regional links in the food system.
- The Center acts as a regional hub, coordinating support services and helping entrepreneurs connect with local, regional, and national resources, including USDA programs.

CAPACITY BUILDING

- The Heartland Food Business Center provides grant funding, or **Business Builder Subaward** (expected late 2024), to support farm and food entrepreneurs in making next-step investments.
- **Helping rural and urban communities build their food system capacity** is a fundamental part of the Heartland Food Business Center's work to build resilient, responsive, and competitive markets for local and regional farm and food entrepreneurs.





