

# Harper County Housing- Cheryl Adelhardt

#### Project Overview and previous work:

- The cities of Anthony, Attica, Harper, and Harper County have joined forces to work on multiple project efforts in Harper County.
- Priority was to complete a Housing Assessment Tool (HAT) for each community.
- Strategy focused on providing a united effort to set priorities and realistic goals.

#### What partners did you involve in the project to address housing?

- Large employers
- Harper & Anthony school districts
- County & City Governments
- Financial institutions
- Community service groups

#### How was housing determined as a priority issue?

The statistics provided a clear picture – from community surveys, town hall meetings, and business surveys. Economic development is dependent on quality, affordable housing to hire, retain, and grow.

#### Unexpected surprises through the process?

The reality of the statistics helped educate not only the committee, but also the community. That educational process promoted the advantage of collaboration. Each community had the same basic needs, but then identified their unique strengths.

# **Linn County Housing- Darcy Wilson**

#### Project Overview and previous work:

In an effort to increase the quality of affordable housing stock in Linn County, we have implemented:

- Neighborhood Revitalization Plan (NRP)
- Completed our Housing Assessment Tool (HAT) as part of the State's updated process.
- These programs will also promote improving residential & commercial properties as well.

#### What partners did you involve in the project to address housing?

- Major Business's within the County

#### How was housing determined as a priority issue?

• Completing the Housing Assessment Tool. Through that process and with its results we now have a good foundation on where to start and what to focus on first.

Did you uncover any unexpected surprises through the process?

Yes, the number of dilapidated homes in the county. It may appear there are vacant homes, but it is because they are unlivable. Revitalization is mandatory for parts of Linn County to survive.

- Completing the HAT has given us a great foundation.
- With this information we will be focusing on applying for the 3rd round of the MIH.
- Creation of new Housing Incentive Programs: Empty Nester, Long Term Vacancy, Paint Linn County





### Wallace County Community Development-Lissa Sexson



#### Project Overview and previous work:

Establish and explore community development and the opportunities that can come from that office. The Rural Champion will evaluate what structure community development should take in Wallace County, and avenues for long-term funding, but also pressing issues such as increasing available housing and diversifying and growing our economic base.

#### What partners did you involve in the project to address housing?

- County Commissioners
- Local Housing Advisory Committee (Reps from City, Schools, Biz)
- Local Investor/Developer

#### How was housing determined as a priority issue?

- Wallace County = 1,500ppl. Housing is a limit to growth, or even sustaining current population
- Housing is a topic in every community conversation, whether at the school, with employers, childcare, recruitment, etc.
