Identifying Development Potential

Pre-Development Activities:

- Identify a viable site
- Coordinate with community partners and key stakeholders to gain public approval
- Evaluate and align your natural assets to potential industry sector developers
- Determine financial feasibility
- Promptly eliminate sites that do not meet basic development requirements



Gathering Site Information

What are the industry standards regarding the availability and development of potential commercial or industrial development sites?

- Site details
- Environmental constraints or wetlands
- Workforce
- Infrastructure
- Topography/Geology
- Utility capacity current and future
- Single ownership to support "speed to market"





What do site selectors look for?

- Location, utilities, access, environmental concerns, infrastructure needs/costs, labor force
- Is the site suitable for the target industry?
- What are the risk factors of the location?
- Emphasize new or unique assets of the area







Site Preparedness Process

- Identification
- Diligence
- Planning
- Marketing
- Development













The Site Visit:

- How is your community best for their investment how does your location reduce cost?
- Was the community welcoming?
- Are the facts that you provided in your application accurate?
- Do you have relevant expertise contributing to the project are the right people available to answer questions during the visit?



LOIS | LocationOne Information System

A national online location analysis tool designed for communities and economic development organizations to promote available site and building inventory.

- Integrated GIS component tool uses customizable layers with market information
- Demographics
- Workforce
- Infrastructure
- Housing
- Business and Industry



What is the Certified Site Program?

A program that is aimed at reducing the risk associated with development by providing detailed information. A designation is issued to properties that have successfully demonstrated that meet the program requirements.

- 1. Ownership
- 2. Property
- 3. Environmental and Cultural
- 4. Access
- 5. Community



Site Certification Designation

A Kansas Certified Site designation is issued to properties that have successfully demonstrated that meet the program requirements.

The established program criteria was designed to signify that a specific due diligence the property is ready for development.







A Kansas Certified Site is a parcel or parcels of land which:

- A local government or locally recognized economic development organization has submitted a compilation of required data specific to support site application.
- 10 contiguous acres at a minimum and controlled by one entity, public or private.
- Primarily to be marketed for business or industrial recruitment or expansion.
- Land is not intended for retail or residential development.





Containing, at a minimum:

- Cleared of dense forestation and underbrush
- Listed on LOIS-LocationOne with complete and current community information or electronic application materials attached to the site page
- Achieved recognition and certification from the Kansas Department of Commerce





Minimum Land Requirements:

- All utilities at site or a formal plan to extend to the site:
 - 6" water main
 - Industrial capacity sanitary sewer
 - Three-phase 12 kV electric infrastructure
- Utilities not in place? Letter from the utility provider(s) may be provided describing process, estimated costs, and timeline required



Site Certification Process

Step One: Contact the Certified Sites Program Manager to determine program eligibility.
